#### RESEARCH

My research focuses on the impact of social policies on children's access to services and on the health and well-being of families and children from historically excluded communities. I take a mixed-methods, interdisciplinary and participatory approach to exploring questions defined in partnership with public service and child/youth advocacy organizations working at the local, regional and national level levels. My approach to these projects engages community partners in a collaborative process of policy learning, prioritizes formal documentation of policy/contextual information, and treats thorough descriptive analysis as a necessary precursor to more complex analysis. My collaborative approach incorporates peer review by intersectoral stakeholders in the report/article production process and prioritizes direct presentation to stakeholder groups as well as dissemination through open-access platforms.

A multidisciplinary research team and a cross-sectoral advisory committee are working to evaluate
interventions funded through the Inuit Child First Initiative, the Inuit parallel to Jordan's Principle.
Currently in design phase, the first component will assess the impact of 6-months of grocery
supports on children, families, and communities in Qikiqtaaluk, Nunavut.

In partnership with Pinaymootang First Nation, documented 12 families' struggles to access equitable services for children with special needs and the impact of these struggles on children, families and the community. This qualitative study directly informed provincial and national level efforts to implement Jordan's Principle.

Used Quebec administrative data to provide a comprehensive portrait of the child welfare trajectories of First Nations and non-Indigenous children. Worked in partnership with the First Nations of Quebec and Labrador Health and Social Services Commission and the Quebec Ministry of Health and Social Services to conduct the study and present results to directors of child welfare, the Commission on relations between Indigenous Peoples and certain public services in Québec, and researcher/practitioner groups.

In partnership with UNICEF Canada, the Canadian Pediatric Society, the Canadian Association of Pediatric Health Centres and the Assembly of First Nations, documented the governmental response to Jordan's Principle and the factors contributing to denials, delays, or disruptions of public services to First Nations children. Findings from this project were covered by over 100 media outlets, mentioned in a speech on the floor of the Canadian Senate, and endorsed by First Nations and child advocacy groups across Canada. Report findings informed efforts to implement Jordan's Principle.

Collected data from ¼ of the Indigenous child welfare agencies in Canada. Developed and worked closely with a national advisory committee throughout the research process. #### **Research Assistant Supervision**
